Objectives

This technical workshop takes place in the context of the MORE project. The main goal of the MORE project is to develop and implement procedures aimed at multimodal road space. Within this framework, we also consider the various ways through which sociopolitical demands, at city level, shape decision- and policy processes and more fundamentally, the ability to develop a holistic approach to the dynamic management of urban road space.

This workshop examines the challenges linked with sociopolitical demands about dynamic management of urban road space in European cities (T2.3). It brings together a small group of knowledgeable stakeholders and observers from within and outside the MORE project in order to get their perspectives on the following topics:

- setting the agenda related to the priority given to different street uses
- advocacy work about street uses and shaping urban road futures
- challenges with public consultation and stakeholders' engagement

Each presenter will be asked to deliver a *20-25 minutes presentation* about his/her organization's vision and strategy about roadspace allocation and the various ways through which it is made material and publicized.

The workshop will provide a unique opportunity for an informal group discussion and feed into future discussions about dissemination.

How to get there

Polis is at walking distance from the European Parliament, Place du Luxembourg, Brussels-Luxembourg train station, and metro station Trône. The address is Rue du Trône 98.



From Brussels-Midi station:

Take the metro lines 2 or 6 direction Simonis (Elisabeth) to Trône and walk five minutes south-east on Rue du Trône.

From Brussels Airport Zaventem (BRU):

A direct train links Brussels airport to Brussels Luxembourg station (every 30 minutes, direction Dinant or Charleroi-Sud). From Brussels-Luxembourg station, turn left and walk on Rue d'Italie, then turn right on Rue du Trône.
